**आदेश / ORDER**

This appeal filed by the assessee is against the directions of Dispute Resolution Panel – 3, Mumbai dated 27.11.2015 passed u/s 144C(5) of the Income Tax Act, 1961 in relation to the assessment year 2011-12.
